#### **JOB SUMMARY:**

Performs advanced (senior-level) inspection work. Performs skilled, professional construction project observation and reporting for evaluation of quality, schedule and conformance with contract documents, regulations, and agency policies. Work involves overseeing and/or conducting inspections and quality control. Works under minimal supervision with considerable latitude for the use of initiative and independent judgment. May supervise others.

### **ESSENTIAL FUNCTIONS:**

- Assures compliance with federal, state and local codes, standards, contractual provisions, regulations and special requirements.
- Evaluates, prepares and maintains inspection records and reports.
- Inspects work for compliance with contract plans and specifications; oversees the investigation of complaints from building occupants or reports of careless or reckless execution of the work.
- Monitors and assists project manager in resolution of RFI's, proposed change orders and submittals.
- Inspects and assesses damage from the construction process in existing buildings as well as new facilities.
- Assists project manager in coordinating activities and schedules with utility companies, contractors, end users/Using Agency and property managers; coordinates necessary "hot permits" with property manager and Facilities Management division.
- Assists project manager in coordinating and policing staging areas, parking and utility shutdowns with Using Agency and/or property manager.
- Monitors impact of remodeling and renovation activities within an occupied building on the environment of the portions of the building that remain inhabited.
- Inspects the project for overall cleanliness and safe approach to the work; monitors the safe management of and storage of hazardous materials utilized in the construction process.
- Assists project manager in coverage of critical early morning and after hour construction activities such as concrete placements and utility shutdowns.
- Monitors the activities of the Construction Materials Testing Firm and the Testing and Air Balancing Company
  to ensure that sufficient resources and quality controls are provided for the project and those contractual
  obligations are met.
- Monitors and provides oversight in the proper and lawful disposal of construction waste and hazardous materials disposal.
- Assists project manager in inspecting the work for proper completion, quality and quantity as it relates to the monthly pay applications
- Assists project manager in inspecting the work for substantial completion and development of punch list.
- Assists project manager in inspection the work for final completion and resolution of final issues.
- Assists in identifying and selecting services for inspection and evaluation.
- Assists project manager with the Project Closeout Procedures ensuring that all closeout documentation is
  received in a timely manner, reviewing completeness of the documentation, and, assisting, coordinating and
  witnessing the operations training for the Using Agency building operators/managers.

- Two (2) years progressively responsible experience providing construction contract administration and inspection services on governmental, commercial or institutional construction projects. Experience may be based on a single specific project type or combination of all listed types.
- Technical certification, licensure, or apprenticeship in one or more trades (Building, Mechanical, Electrical, Plumbing or Combination) is preferred.
- Prior experience in observation, contract administration, or quality control with a professional Architectural / Engineering firm providing construction administrative services is preferred.
- Education and experience may be substituted for one another on a year-for-year basis.
- Valid State of Texas Class "C" driver's license.

Interviewee selection is based on applicant information explaining how they meet each Competency (Knowledge, Skills and Abilities) requirement. Follow application instructions and fill out application form completely for further consideration.

Official transcripts or other minimum requirement validations will be requested at the time of the conditional job offer.

As part of its employment process, TFC may procure or have prepared a criminal background check. An applicant with an unsatisfactory criminal background check report is ineligible to be hired for the position for which the report is initiated.

Driver's record check will be conducted by the agency. Satisfactory driving records are required for driving state or personal vehicles and motor driven equipment to conduct agency business.
