

TDCJ Computer Recovery Authorized DM15 Class Codes

All state property class codes listed below will be coded and released back to the owning agency as DM5C, this process is automated and will take place once the mandatory 10-business day advertising period has ended. State agencies should only dispose of these properties using DM 15, unless a different code is authorized by TFC prior to disposal. If a state agency believes they have property that should be disposed of using DM 15, and the class code is not one listed below, an email request will need to be sent to TFC. These requests must include pictures of the asset, property number, condition, and where it is located. Property cannot be disposed of with TDCJ Computer Recovery until our office has authorized each asset for disposal as DM5C, per the Comptroller.

State Property Accounting (SPA) User Guide defines DM 15 as the following:

Disposal Method 15 (Surplus Sent to the TDCJ Computer Recovery Program)

This disposal method is used for data processing equipment **not** sold or transferred through the surplus process or by other means. This disposal method should be used to delete data processing equipment after pickup by TDCJ.

Note: Data processing equipment is defined as central processing units, front-end processing units, mini-processors, microprocessors and related peripheral equipment such as data storage devices, document scanners, data entry equipment, terminal controllers, data terminal equipment, computer-based word processing systems other than memory typewriters and equipment and systems for computer networks.
